4. Careless, reckless, or imprudent driving.
5. Violations of speed limits exceeding 25 miles per hour over the posted limit.
6. Any traffic ticket which is deemed not appropriate by the Clerk of the Municipal Court or Municipal Judge, to be accepted and paid through the Traffic Violations Bureau.


